**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF INDIAN WELLS,
CALIFORNIA, ADOPTING A NEW CITY SEAL LOGO**

WHEREAS, the City of Indian Wells recognizes the importance of a modern and cohesive visual identity that reflects the City's values, heritage, and vision for the future; and

WHEREAS, the current City Seal has served the community for many years, but no longer fully represents the evolving character and aspirations of Indian Wells; and

WHEREAS, City Council directed staff to initiate a design process to develop a new City Seal logo that is inclusive, distinctive, and representative of the City's unique identity; and

WHEREAS, there are no other in-place public utility facilities that are in use and would be affected by the vacation; and

WHEREAS, after a thorough review of design concepts and recommendations from City staff and design professionals, the City Council has selected a new City Seal logo that embodies the City's commitment to excellence, innovation, and community pride; and

WHEREAS, the new City Seal logo will be used on official City documents, signage, digital platforms, and other materials to ensure a consistent and professional representation of the City of Indian Wells.

WHEREAS, The City Council hereby adopts the new City Seal logo, as presented and attached hereto as Exhibit A, as the official seal of the City of Indian Wells.

WHEREAS, The City Manager, or their designee, is authorized and directed to take all necessary steps to implement the new City Seal logo across City departments, communications, and materials.

WHEREAS, The previous City Seal shall be retired from official use, except where historical reference or archival purposes require its display.

WHEREAS, all other legal prerequisites to the adoption of this Resolution have occurred.

NOW, THEREFORE, BE IT RESOLVED DETERMINED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF INDIAN WELLS AS FOLLOWS:

SECTION 1. Incorporation of Recitals. The City Council hereby finds and determines that the Recitals of this Resolution are true and correct and are hereby incorporated into this Resolution as though fully set forth herein.

SECTION 2. Certification, Recordation and Retention. The City Clerk shall cause a certified copy of this Resolution, attested by the City Clerk under seal, to be recorded without acknowledgment, certificate of acknowledgment, or further proof in the Office of the Riverside County Recorder. The City Clerk shall permanently maintain a true and correct copy of this Resolution in the City Clerk's Office.

SECTION 3. Effective Date. This Resolution shall become effective upon its adoption.
