A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF INDIAN WELLS, CALIFORNIA, RECITING THE FACTS OF THE CONSOLIDATED GENERAL AND SPECIAL MUNICIPAL ELECTION HELD IN THE CITY OF INDIAN WELLS NOVEMBER 8, 2022, DECLARING THE RESULTS THEREOF, AND SUCH OTHER MATTERS AS ARE PROVIDED BY LAW

WHEREAS, a consolidated general municipal election was held and conducted in the City of Indian Wells, County of Riverside, State of California, on Tuesday, the 8th day of November 2022, as required by law; and

WHEREAS, notice of said election was duly and regularly given in the time, form and manner provided by law; voting centers were properly established; election officers were properly appointed; and in all respects said election was held and conducted, the votes cast thereat were received and canvassed, and the returns were made and declared in the time, form and manner required by the provisions of the Elections Code of the State of California for conducting elections in cities; and

WHEREAS, the County of Riverside has canvassed the returns of said election and the Registrar of Voters has certified the results to this City Council, which results are received, attached, and made a part hereof as Exhibit "A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF INDIAN WELLS, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION <u>1</u>: There was one (1) voting center established for the purpose of holding said election consisting of the regular and special election precincts in the City of Indian Wells as established for the holding of State and County Elections.

SECTION 2: The whole overall number of registered voters in Indian Wells is 3,280. The at large number of ballots cast in the City was 2550 making a turnout total of 77.74 %.

SECTION 3: The names of persons voted for said regular election for two Members of the City Council of the City of Indian Wells are as follows:

Bruce Whitman Dana Reed Toper Taylor Douglas Hanson Ivan Moad

SECTION 4: The names of persons voted for said special election for one Member of the City Council of the City of Indian Wells are as follows:

SECTION 5: The number of votes given at each voting centers and the number of voted given in the City to each of the persons above named for the respective offices for which the persons were candidates are listed in Exhibit "A", attached.

SECTION 6: The City Council does declare and determine that:

Bruce Whitman and Dana Reed were elected as Members of the City Council for the term of four years to December 2026; and

Edward Ty Peabody was elected as Member of the City Council for the term of two years to December 2024.

SECTION 7: The City Clerk shall enter on the records of the City Council of the City of Indian Wells, a statement of the results of said election, showing:

- a. The whole number of votes cast in the City;
- b. The names of the persons voted for;
- c. What office each person was voted for;
- d. The number of votes given at each precinct to each person;
- f. The total number of votes given in the City to each person

SECTION 8: The City Clerk shall immediately make and deliver to the person so elected a Certificate of Election signed and duly authenticated; and the City Clerk shall also administer to said person elected the Oath of Office prescribed in the State Constitution of the State of California and shall have him subscribe thereto and file the same in the Office of the City Clerk, whereupon said person so elected shall be inducted into the respective office to which he has been elected.

SECTION 9: The City Clerk shall verify the passage and adoption of this Resolution and shall enter the same in the book of original resolutions of said City.
